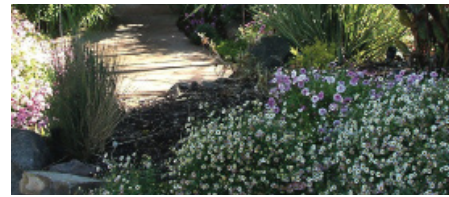
BY SUBMITTING THIS APPLICATION, YOU AGREE TO THE FOLLOWING:

I, the undersigned, understand that this is a limited, first-come/first-served, one-time program, that rebates are given only for projects for which applications are approved and that ZONE 7 is entitled to deny any application that does not meet program requirements. I have voluntarily determined to participate in ZONE 7's Smart Irrigation Controller Program. I agree that ZONE 7 may visit the premises and verify existing conditions and that the installation has been performed. By virtue of these inspections, I understand that ZONE 7 makes no determination with respect to whether materials and equipment are free of defects, the quality of the workmanship, or the suitability of the premises, materials or equipment for the installation. I also understand that the installation of a Smart Controller may not result in lower water bills. If this Application is approved by ZONE 7 and the work proceeds, I agree to defend, indemnify and hold harmless ZONE 7, its directors, officers, agents and employees against any and all loss, liability, expense, claims, suits and damages, including attorneys' fees, arising out of or resulting from the installation of a Smart Controller. I authorize my water retailer to make water consumption data available to Zone 7 for the purpose of measuring the success of these programs in conserving water. I agree to a pre- and/or post-installation inspection, upon request.

ZONE 7 WATER AGENCY



TO QUALIFY FOR A REBATE:

- Applicant must be a customer of a retail water agency within Zone 7's service area (Dublin San Ramon Services District, City of Livermore, or City of Pleasanton)
- Applicant's water account must be in good standing.
- Site must have a dedicated potable water irrigation meter(s) or landscape sub-meter(s) to measure all landscape water use.
- Site must have history (single-family 1 year and CII past 3 years) of water use and a landscape water budget.
- Applicant must select, purchase and install a Smart Irrigation Controller from the *EPA WaterSense Weather-based Irrigation Controller List* of approved controllers (Smart Hose/Faucet Type Timers are not included in this rebate program). All areas on site must be converted to Smart Irrigation Controller(s) to receive a rebate.
- Installation must be complete before applying for rebate. You must provide a picture of the installed controller and a Screenshot of the controller settings including zones and watering schedule.
- Rebate application must be postmarked within 60 days of purchase date.
- Controller must remain on- site for a minimum of two (2) years. It take up to 8 weeks to process your rebate. You will receive a credit to your water bill. Check your billing statement(s). The Smart Controller maximum rebate in 2019: is up to 50% of the customer costs with a maximum rebate of \$75 for single-family residences, \$100 for multi-family residences, or \$3,000 CII.

Funding is limited. Rebates are one-time-only per site, and will be provided on a first-come, first served basis.

You have two options for submitting your rebate application:

(Electronic submittal preferred, but not available to Mac users.)

1. Complete the electronic Smart Controller rebate application available at www.zone7water.com under **Conservation & Rebates**. Scan your original sales receipt(s), watering schedule screenshots, and water account bill and save as PDF files. Email a copy of application and the scanned sales receipt(s) and water bill to: rebates@zone7water.com. If unable to send electronic attachments, you may fax a copy of your electronic application, the original sales receipt(s), watering schedule screenshot and water account bill to 925- 454- 5726 within 24 hours of submitting the electronic application.

2. Mail the application, a copy of the dated sales receipt listing the price of the Smart Controller, a copy of your water bill, picture of your installed controller and screenshots of your controller settings to: Rebates

PROJECT INFORMATION:

- You must be “replacing” an existing controller.
- Single-family residences must have a minimum of 500 square feet of irrigated lawn with at least 4 stations. One Smart Controller per single-family property will be rebated.
- Multi-family and CII customers must have a dedicated irrigation meter. One controller per water account.
- All irrigated areas must be converted to a new Smart Controller. Smart Hose/Faucet Timers not included in this rebate program.

For CII customers: one controller per water account.

APPLICATION STEPS:

1. Complete your application
2. Attached a copy of your receipt
3. Include a picture of your installed controller and a screenshot(s) of your controller programming settings.
4. Submit the above document and pictures electronically or by mail.

REBATE INFORMATION:

- The Smart Irrigation Controller you purchase must be from the EPA WaterSense Weather-based Irrigation Controller Product List. The List can be found at <https://www.epa.gov/watersense/product-search>: Smart Hose/Faucet Timers not included in this rebate program.
- Sales tax, installation, programming costs, and other fees are not rebated.
